#### 6.2 Notice of Motion

#### Whereas:

Several Renewable Energy companies, including manufacturers of solar panels, solar panel mounting and wind turbine components, are investing millions of dollars in the Windsor area and creating jobs.

#### Whereas:

In order to maintain this positive momentum, these companies will require, and deserve, the patronage of local consumers.

#### Whereas:

The City of Windsor and Essex County Communities are contemplating or planning installations of Solar and other Renewable Energy technologies on publically-owned facilities.

## Therefore Be It Resolved That:

The City of Windsor and Essex County Communities patronize local Renewable Energy manufacturing, accessory and installation and service firms when contracting installation of Renewable Energy technologies on city-owned facilities.

#### Further Be It Resolved That:

The City of Windsor and the County of Essex express formal support for the Green Energy and Economy Act through adoption of this resolution and join in efforts to maintain the act.

The Committee generally discusses:

- The purchasing policy of the City of Windsor and the effectiveness of this resolution;
- That "the lowest bid ....not necessarily accepted" caveat in Purchasing Bylaw;
- If the bidder is local, and the project/commodity is local could the local content be recognized and weighted differently in the tendering award process;
- The wording "patronize" is considered to be interchangeable with the word "customer";

• The Committee considers an addition to the last paragraph of the Notice of Motion:

- The environmental costs of transportation for the goods/services purchased must be considered.

## WECEC Air Subcommittee Update - June 2011

1. The U.S. Nuclear Regulatory Commission (NRC) Atomic Safety and Licensing Board (ASLB) presiding over the Fermi 3 combined construction and operating license application (COLA) proceeding ruled on May 20 against nuclear utility DTE's motion for summary disposition on two contentions against the proposed new reactor brought by an environmental coalition. The first contention concerns risks of Fermi 3's construction and operation exacerbating the proliferation of toxic algae in Lake Erie. The second involves risks to an endangered indigenous species -- the Eastern Fox Snake -- from the proposed new atomic reactor.

The environmental coalition includes Beyond Nuclear, Citizens for Alternatives to Chemical Contamination, Citizens Environment Alliance of Southwestern Ontario, Don't Waste Michigan, and the Sierra Club Michigan Chapter. It argued that the proposed Fermi 3 atomic reactor's thermal and chemical discharges to Lake Erie's shallow Western Basin would provide ideal conditions for the spread of a harmful cyanobacteria, Lyngbya wollei. The ASLB agreed with the environmental intervenors, that planned calcium discharges into Lake Erie from Fermi 3, as well as scientific documentation of the algae's presence mid-way between Detroit Edison's Fermi nuclear power plant and its coal-burning Monroe Power Plant, merit further study in a full evidentiary hearing.

Similarly, the ASLB ruled in favor of a full hearing on the risks of Fermi 3's construction upon the Eastern Fox Snake. Although Detroit Edison has now admitted sitings of the endangered species on its Fermi nuclear power plant site, has slightly modified its construction location, and has drafted a mitigation plan, the ASLB agreed with the environmental intervenors that the Michigan Department of Natural Resources and Environment's (MDNRE) approval is required, as well as more careful study of the impact of construction traffic upon the endangered species.

2. The Ontario government will not, with its current programs, meet its targets for reducing greenhouse gases (GHGs). This is one conclusion from the Environmental Commissioner of Ontario's 2011 Greenhouse Gas Progress Report, released May 31st. # **Windsor Trolley Proposal**

Brief discussion on Windsor Star article of April 14<sup>th</sup>/'11 on the pros and cons of the proposal. On first glance, the subcommittee does not believe this is a viable project. Though commendable from a historical point, investing in the existing transit system which needs real funding in keeping with the Master Transit Plan should be the priority. At this time the subcommittee asks for more information on the proposal should it go forward or receives more study.

## Recommendations

That the subcommittee and WECEC be kept appraised of all and any developments on this proposal as they arise.

# **Moving of Main Library to Aquatic Centre Proposal**

Discussion commenced based on Windsor Star article of May 10/'11. The subcommittee feels there is a transportation component as well a larger environmental consideration to this proposal.

The present library is well situated on the main street, meets the needs of a vibrant local community, convenient both by pedestrian and bus access. The library gets excellent usage by citizens and still a viable building. Renovations if and when required would be more economically and environmentally sound than moving a key component of the downtown from its immediate residential area to a less accessible corner of the downtown core.

## Recommendation

Whereas, the present main library where it situated is a viable component of a livable city, accessible to the public, meets the needs of the community and is not necessary to the aquatic centre proposal going forward;

And whereas, moving the library rather than renovating the existing building is not sound from either an environmental or economic perspective;

Be it resolved, that the main library remain in its present position, not be considered part of the aquatic centre proposal and that renovations and upgrade appropriate to its continued and future use be considered and allocated as possible

# **Airport Master Plan**

The subcommittee has been tasked to review and make recommendations to WECEC. The master plan will be shown at a public meeting on Monday May 30<sup>th</sup> with a commentary period of two weeks. The file on the master plan is considerable and would not allow the subcommittee sufficient time to review it adequately. The subcommittee notes that most review/commentary periods are around 45 days in length. The subcommittee chair has received some information on the master plan, but will not receive the entire file until after the June WECEC mtg.

## Recommendation

The subcommittee asks for a 30 day extension in order to review the file and report back at the July WECEC mtg.

Dear Honourable Sandra Pupatello,

The purpose of this letter is to bring to your attention the concerns of the local environmental community regarding the compensation for Provincially Significant Wetlands (PSWs) that will be lost due to the construction of the Windsor-Essex Parkway. Our goal is to arrange a face-to-face meeting with representatives from the Ontario Ministry of Transportation to discuss the compensation strategy for PSWs.

The Public Advisory Council (PAC) is a grass roots organization associated with the Detroit River Canadian Cleanup (DRCC). PAC members represent Non-Governmental Organizations and private citizens. The PAC provides a route through which the public can provide input on the cleanup of the Detroit River and its watershed. The PAC has identified negative effects of the Windsor-Essex Parkway concerning two key beneficial use impairments (BUI) outlined in the Remedial Action Plan for the Detroit River. They are BUI #14 the loss of fish and wildlife habitat and BUI #3 the degradation of fish and wildlife populations.

We understand the Windsor-Essex Parkway will have significant social and economic benefits to Windsor and the Province of Ontario. The Windsor-Detroit border is the most important trade corridor between the United States and Canada accounting for 40% of trade between the countries. However, the construction of the Windsor-Essex Parkway will have significant impacts on the local environment. Many concerns have been addressed through permits issued to the Ontario Ministry of Transportation (MTO) by the Ontario Ministry of Natural Resources (OMNR). However, a major issue not addressed through these permits is the loss of 8.9 hectares of Provincially Significant Wetlands (PSWs) in the corridor.

Wetlands are among the most productive and diverse ecosystems in the world. Provincially Significant Wetlands have been evaluated by the OMNR using the Ontario Wetland Evaluation System and are considered to be especially valuable because they contain social, hydrological, biological and/or special features. Both the Province of Ontario and the Government of Canada have committed to preserving wetlands in the Great Lakes region through the Great Lakes Wetlands Conservation Action Plan. Additionally, the Ontario Planning Act Provincial Policy Statement reflects PSW importance in the following directive "development and site alteration shall not be permitted in significant wetlands". The Southern Ontario Wetland Conversion Analysis released by Ducks Unlimited Canada in 2010 indicates that 72% of wetlands in Southern Ontario have been lost.

Members of the PAC have reached out to members of the Windsor-Essex Mobility Group to discuss compensation strategies for the loss of PSWs at Public Consultation Sessions. Unfortunately, the Windsor-Essex Mobility Group is unable to answer our questions concerning compensation for loss of PSWs.

Specifically our questions regarding the amount and type of compensation required have not yet been addressed. We have explained potential strategies to compensate for lost wetlands to the Windsor-Essex Mobility Group, but unfortunately get the impression that our strategies are not being seriously considered. We wish to work with the Windsor-Essex Mobility Group and the Ontario Ministry of Transportation to ensure that compensation requirements for PSWs are met.

It is our hope that you will facilitate a meeting between representatives of the Detroit River Canadian PAC and the Ministry of Transportation. Additionally, representatives from the Ontario Ministry of Natural Resources and the Windsor-Essex Mobility Group could be invited to attend to act as advisors. We are willing to present compensation strategies that would facilitate the development of the Windsor-Essex Parkway in an ecologically sound manner. The question we would like answered at the proposed meeting: If in fact compensation is required for loss of provincially significant wetlands, how many hectares of compensation lands are required to fulfill this obligation?

Please confirm that you will assist the Detroit River Canadian PAC by arranging a meeting for us with a representative of the Ministry of Transportation and the other parties. Thank you for your time and consideration.
