In response to a question asked by P. Drca regarding where A. Parent's direction will be derived, Councillor Hatfield responds that direction will come from motions passed by the Committee and from contact with members.

5.2 **Airport Wetlands Buffer**

Mayor Francis is not present to provide information relating to the Windsor Airport wetlands buffer.

The Report of the City of Windsor Planning Advisory Committee dated August 19, 2020 entitled "Official Plan Amendment – Provincially Significant Wetlands" is **attached** as Appendix "A" for information purposes.

Discussion ensues regarding the following motion approved by WECEC at its meeting held June 3, 2010:

Moved by F. Butler, seconded by P. Cheslock,  
"That the 240 metre buffer required for the protection of the provincially significant wetlands and woodlots as recommended in the Environment Canada document entitled "How much Habitat is Enough" **BE APPROVED.**"

P. Roberts indicates that the vision of buffering is not specific to the Windsor Airport woodlots as the 120 metres in some aspects are appropriate.

Councillor Halberstadt suggests that a tour be coordinated to include the woodlots/wetlands at the Windsor Airport and the Ojibway Shores.

Moved by Councillor Halberstadt, seconded by R. Coronado,  
That administration **BE REQUESTED** to contact the General Manager of the Windsor Airport for permission to allow the members of the Windsor Essex County Environment Committee to tour the wetland/woodlots at the Windsor Airport  
Carried.
