5.3 **Draft Notice of Motion – Ojibway Shores Development Proposal by the Port  
Authority**

Moved by T. Stomp, seconded by J. Costa Gardner,  
That Rule 13.9 of the Procedure By-law 98-2011 regarding business not already  
before the Windsor Essex County Environment Committee **BE WAIVED** to permit the  
introduction of a motion for consideration without prior notice regarding the Windsor  
Port Authority and clear-cutting Ojibway Shores and accepting fill.  
Carried.

An e-mail from Transport Canada Minister Lebel dated June 28, 2013 regarding the Draft Notice of Motion relating to the proposed development of Ojibway Shores is distributed and attached as Appendix "A".

Moved by Councillor Payne, seconded by T. Stomp,

**WHEREAS** the Windsor Port Authority is determined to proceed with clear-cutting Ojibway Shores for the purpose of storing fill on this Candidate Natural Heritage Site #37 which contains Carolinian flora and fauna species and which is the only river gateway providing ecological linkage to Windsor's environmentally sensitive sites stretching back to the Springarden ANSI. This action is in direct contradiction to the June 11, 2013 letter from Transport Canada Minister Lebel (attached) prohibiting such action.

**THEREFORE BE IT RESOLVED** that a letter **BE SENT** to the Honourable Denis Lebel, Minister of Transport, Infrastructure & Communities asking him to inform the Windsor Port Authority that they **CANNOT** proceed with the clear-cutting of Ojibway Shores **NOR** accept fill as they intend to start September 1, 2013.

Councillor Halberstadt, Co-Chair requests the foregoing Notice of Motion be added to the July 8, 2013 City Council Communications package.

## 6. COORDINATOR'S REPORT

A. Parent reports approximately 20 participants attended a tour of the Humbug Marsh along with a presentation by Dr. John Hartig, Refuge Manager. She states Dr. Hartig discussed the process by which Humbug Marsh was saved from development as well as highlighted many ongoing Brownfield restoration and manmade wetlands sites.

P. Roberts indicates there is a need to register properties on the Canadian side. He notes there are American dollars available to acquire and/or restore properties of significant ecological importance on the Canadian side of the Detroit River.

A. Parent advises on June 7, 2013 WECEC continued their Green Speaker Series with host Dan Burden, Co-Founder and Director of Innovation and Inspiration at the Walkable and Livable Communities Institute. Mr. Burden spoke to approximately 100 participants regarding how the creation of walkable streets can contribute to healthier, more vibrant communities with thriving economies. She notes the walking audit took place in the Walkerville and Wyandotte Street Business Improvement Areas. Mr. Burden pointed out many simple solutions to begin improving walkability which included clearly viable crosswalks and signage were often missing from city streets. He suggested using bumpouts at intersections, diagonal parking along side streets and more greenery and places to sit.

Councillor Halberstadt, Co-Chair indicates the Planning Department will meet with the Wyandotte and Walkerville Business Improvements Areas to discuss the possibility of implementing Mr. Burden's recommendations.

Councillor Halberstadt, Co-Chair advises Mr. Burden noted some city streets can be narrowed (to allow for bike lanes). However, in speaking with the Manager of Transportation Planning, it was relayed there is a federal standard to abide by in Canada and indicated the standards are different in the United States.

J. Bryant indicates the Federal Standard for road widths can be found in the Transportation Association of Canada Guidelines.

### 7.3 Provincially Significant Wetlands (PSW)

P. Roberts states members of the PSW subcommittee attended the Windsor Port Authority's public meeting held July 3, 2013 at Mackenzie Hall regarding potential development on the Ojibway Shores property. He is interested in ascertaining the lease value the Port Authority can generate on these lands.

P. Roberts reports a letter is in progress to invite Richard Wyma, General Manager, ERCA and Dr. John Hartig, Refuge Manager, Detroit International Wildlife Refuge to a meeting in Windsor to discuss how best WECEC and resources can be of assistance to move the International Wildlife Refuge forward on the Canadian side.

P. Roberts advises a report will be forthcoming to City Council regarding a request to designate several parks in Windsor as part of the International Wildlife Refuge. A. Parent indicates the motion if passed (Committee Report) will accompany the report to Council.

Moved by T. Stomp, seconded by C. Wright,

**WHEREAS** the City of Windsor will be receiving a report regarding the designation of City of Windsor Park properties as part of the Detroit River International Wildlife Refuge; and

**WHEREAS** Windsor's unique natural resources could be seen as part of the Detroit River International Wildlife Refuge that would result in positive public relations and would help in marking the City and region; and

**WHEREAS** the Detroit River International Wildlife Refuge is a unique partnership with Canada and offers Windsor more opportunities to leverage human and financial resources for wildlife management, research, and education; and

**WHEREAS** being part of the Detroit River International Wildlife Refuge would help Windsor become part of major celebrations such as International Migratory Bird Day, World Wetlands Day; and

**WHEREAS** there would be no costs associated with park designation of certain Windsor parks nor any loss of ownership rights as part of the Detroit River International Wildlife Refuge;

**THEREFORE BE IT RESOLVED** that City Council favourably consider designating the recommended parks as part of the Detroit River International Wildlife Refuge.

Please see below Notice of Motion which will be brought forward at WECEC on Thurs July 4<sup>th</sup> in relation to the propose development of Ojibway Shores:

WHEREAS the Windsor Port Authority is determined to proceed with clear-cutting Ojibway Shores for the purpose of storing fill on this Candidate Heritage Site which contains Carolinian flora and fauna species and which is the only river gateway providing ecological linkage to Windsor's environmental sensitive sites stretching back to Springarden ANSI. This action is in direct contradiction to a June 11th 2013 letter from Transport Canada Minister Lebel (attached) prohibiting such action.

THEREFORE BE IT RESOLVED THAT a letter be sent to Minister Lebel asking him to inform the Windsor Port Authority that they CANNOT proceed with the clear cutting of Ojibway Shores to accept fill as they intend to starting Sept 1st 2013.

Also attached is a letter dated June 28<sup>th</sup> from many environmental groups to Minister Lebel asking that he support his previous statements and prohibit the Port Authority from clearing Ojibway Shores.


**I cannot stress enough the importance of a large crowd at the upcoming public meeting Wednesday July 3<sup>rd</sup> at 6:30pm at Mackenzie Hall. It will be one of our greatest actions to fill the room and show all that Windsor cares about this property.**
