### **6. Business Items**

#### **6.1 “Before the Flood” Film Screening**

K. Richters advises two showings of the film entitled “Before the Flood” will be shown at the Lakeshore Cinemas on November 2, 2017 at 10:00 a.m. (for students) and also at 7:00 p.m. at a cost of \$1,130. per showing. She adds students from Massey and Riverside High Schools will be attending the early showing and transportation will be provided by WECEC. Following the evening showing, there will be a discussion on climate change featuring a panel of experts.

### 6.3 Environmental Master Plan Public Consultations

K. Richters indicates the Environmental Master Plan (EMP) was tabled at the meeting of the Environment, Transportation & Public Safety Standing Committee held October 18, 2017 to allow for public consultation until January 1, 2018. She adds the 2017 EMP proposed changes includes the following:

- Goal A – Improve Our Air Quality – To be proactive by partnering with community groups, industry and other levels of governments to improve Windsor’s air quality.
- Goal B – Improve our Water Quality – To be proactive in managing wastewater, stormwater and potable water to improve Windsor’s water quality.
- Goal C – Sustainable Land Use – To enhance our community through naturalization, reforestation, park and urban planning, densification and community initiatives.
- Goal D – Increase Resources Efficiency – To increase resource efficiency, conserve water and energy and reduce waste.

K. Richters states six events regarding the Environmental Master Plan have been arranged to allow for public engagement as follows:

- November 28, 2017 – Windsor Public Library –Central Branch-11am-2pm
- November 29, 2017 – St. Clair College – 11am-2pm

### 8. Subcommittee Reports

#### 8.1 Air

D. Coronado refers to Agenda Item 10.1 and the Permit to Install application for a new simple cycle combustion turbine generator located at 2400 Miller Road, Dearborn, Michigan. It is noted in the "Public Participation Documents for Dearborn Industrial Generation, L.L.C." that the following statement is provided – "***The facility is located in Wayne County, which is meeting all of the NAAQS standards, set by the United States Environmental Protection Agency (USEPA), except for sulphur dioxide.***"

D. Coronado expresses concern with the cumulative impacts of pollution and the sulphur dioxide emissions.

Moved by Councillor Francis, seconded by Mayor Nelson Santos,

That the update provided by D. Coronado relating to the Air Subcommittee and the Permit to Install application for a new simple cycle combustion turbine generator located at 2400 Miller Road, Dearborn, Michigan **BE RECEIVED.**

## 8.2 Environmentally Sensitive Lands and Issues

The Chair refers to the Windsor Star article dated October 25, 2017 entitled "*Cost to protect Ojibway Shores should not fall on taxpayers, Masse says.*" It is noted in the article that the "*Port Authority CEO David Cree said he was prepared to work with the city and ERCA so there would be enhancement and maintenance of Ojibway Shores. He guessed the amount to secure a deal would be in the \$10-million range over 30 years.*"

D. Coronado submits a suggested resolution relating to the Ojibway Shores, **attached** as Appendix "A". He states the Ojibway Shores is not currently a protected property with the federal government. In terms of the resolution, M. Nelson expresses concern relating to the species at risk.

Councillor Francis states the federal government could transfer the Ojibway Shores to the City of Windsor.

Moved by D. Coronado, seconded by D. Grant,

**WHEREAS**, the City of Windsor has committed to enhancing the quality of Windsor's natural environment; and

**WHEREAS**, the property known as Ojibway Shores and owned by the Windsor Port Authority, has important natural heritage characteristics, including significant wetland, habitat of threatened and endangered species, significant woodlands, significant wildlife habitat, ecological function, diversity, significant species, significant communities, and condition; and

**WHEREAS**, the 2020 biodiversity goals and targets for Canada include by 2020 at least 17 percent of terrestrial areas are conserved; and

**WHEREAS**, the Government of Canada is the sole shareholder of the Windsor Port Authority;

**THERE BE IT RESOLVED** that the City of Windsor request the Government of Canada conserve the significant natural condition, biodiversity and biological function of the Ojibway Shores property as an environmentally protected area.

Carried.

## 5. Presentations and Delegations

### *Energy Efficient Home & Lifestyle*

Michael Schneider is present to provide information relating to his energy efficient home and lifestyle that includes solar panels and an electric car. The Powerpoint entitled “Green Speaker Series” is ***attached*** as Appendix “D”. Highlights of the presentation and additional comments are as follows:

- The objectives outlined in the presentation includes:
  - Reduce domestic energy consumption
  - Become more energy efficient
  - The home was initially ranked Energuide Energy Efficient at 64
  - A typical Canadian home is ranked at 57
  - Initial goal was to improve the energy rating.
- Because of poor insulation in the attic of the home, heat radiation to the inside of the house was seen and loose-fill insulation was installed.
- In terms of the exterior doors, infrared pictures revealed a hollow core door with air leaking at the bottom. A new energy star rated exterior door was installed.
- Today’s furnace efficiency is ranked between 92 and 95 percent with variable speed DC motors.
- By replacing toilets, consumption per flush is reduced by 66 percent.
- Energy efficiency of the home is now at 91.
- The energy consumption in the home was reduced in 5 years at a cost of approximately \$25,000, and, through various government programs he was refunded \$12,000.

D. Coronado indicates with the completion of the Community Energy Plan, he suggests linking it to M. Schneider’s presentation. Suggestion to invite Essex Powerlines and Enwin to a future meeting of WECEC to discuss energy efficiencies.

In terms of the Green Speaker series, it is suggested M. Schneider speak to issues such as home energy, electric cars and transportation.

K. Williams proposes M. Schneider also discuss the costs of what homeowners can do on their own, investments they can make and the resultant savings.

Moved by D. Coronado, seconded by J. Passa,

That **APPROVAL BE GIVEN** to an expenditure in the upset amount of \$200 as an honorarium for Michael Schneider who will be a Green Speaker on a date to be determined in December 2017.
